Courses included: English Language Arts 30-1, English Language Arts 30-2, French Language Arts 30-1, Français 30-1, Mathematics 30-1, Mathematics 30-2, Chemistry 30, Physics 30, Biology 30, Science 30, Social Studies 30-1, Social Studies 30-2.

Commentary and Analysis: Elm Street School has maintained excellence in Education Quality and Parent Involvement and we attibute this to the partnership between all stakeholders and our strong focus on foundation skills in literacy and numeracy. Access to Supports has a maintained feedback score, where Elm Street School results indicate that we are "Good." We are working to be transparent in how and what we do support to all stakeholders as in discussion with differing parties. It has come up that not all supports are well known to all parties. At Elm Street School, we recognize that students indicated feeling low engagement, where parents and teachers gave high scores in this area. Being that students are our main priority for our work, Elm Street School will work towards ensuring students discover how they learn best and can feel engaged at school. Citizenship is also a goal for this year, having a higher focus on digital citizenship as this affects so many individuals in our current society. With a focus on digital citizenship and building leadership opportunities with students, our hope is to create an atmosphere that is more welcome for students.

Commentary and Analysis: Results show that we only had 3 parents that filled out the survey (Gr. 4 parents are sent information to complete the survey). We will work on getting more information from parents to support with perspectives from this party. Teachers demonstrated a 95.2% measure on students being engaged in school, while students rated this a 54.4%. As students are our main priority, we want to ensure we work on supporting them on what engagement can look like, along with feeling success in school.

We have made this our goal in wellness to support students with digital citizenship efforts and we have updated our school policies to support students with digital (consequences for cyberbullying, cell phone usage prohibited during school hours and instruction around the unknown consequences of digital at a young age).

Often, stakeholders believe that our Family School Liaison Worker is the only resource. We have become transparent about our HUG/My Place support, connections with the community, CASA programming referrals and our school goals to support in the area of wellness. We have found that the area where it has been communicated wanting more supports are in socioemotional supports, rather than academic of services in OT, PT and Speech.

This may be adjusted next term, in consultation with our parent council. So far, parent council has voted on the first Tuesday evening of the month from 6-7PM being an opportunity for parents to meet at school or via online link.
